1	<ul style="list-style-type: none">• MATIT: Payment deadline of the Consolidated Liability Coverage for Townships with July Renewals.• All assessments of real and personal property are finalized. No changes may be made after this date except where authorized. MS § 274.175.
14	For towns that have November elections: Last day to publish notice of town offices to be elected. Notice to include first and last dates to file for town office, and the required hours on last day of 1:00 - 5:00 pm (2 weeks before filing opens) MS § 205.13, subd. 2.
17	For towns that have November elections: Last day to post notice of town officers to be elected. Notice to include first and last dates to file for town office, with required hours of 1-5 pm on the last day. (10-days notice) MS § 205.13, subd. 2.
28	For towns that have November elections: Last day to designate location for absentee voting for general election—at least 14 weeks prior to election. MS § 203B.081.
31	<ul style="list-style-type: none">• Deadline for mailing Federal and State Payroll Reporting Forms for Second Quarter.• MN Unemployment Quarterly Report due.
July 28- Aug 11	For towns that have November elections: Candidate filing period—opens 98 days before election and closes 84 days before election. MN Stat § 205.13, subd 1a.
Aug 4- 27	MAT District Meetings Various Dates—see dates above in calendar. Location details can be found in Township Insider magazine or www.mntownships.org
