13	<ul style="list-style-type: none">• Required TIF information published in newspaper of general circulation. MS § 469.175, subd. 5.• Last day for claimants to file for Property Tax Refund, Form M-1PR.• For towns that have November elections: Last day for a candidate to withdraw from a town election until 5:00 pm. (2 days after filing closes) MS § 205.13, subd. 6.
